- 1 The filling up of the above posts shall be on need basis and purely temporary
- 2 ***The engagement of the candidates in these posts does not confer any right or title to claim permanent appointment.***
- 3 All the details furnished in the offline application will be treated as final and no changes shall be entertained.
- 4 Applications without photograph, Signature and necessary Marks cards, certificates in support of their application shall be summarily rejected.
- 5 The qualifications prescribed should have been obtained through recognized Universities/ Institutions.
- 6 The prescribed Essential Qualifications are a bare minimum and mere possession of it, will not entitle the candidates to be considered for the post. The candidates should furnish all the Qualifications and Experience possessed in the relevant field, over and above the minimum qualifications prescribed for consideration of their candidature. **Rehabilitation professionals shall hold a valid registration with RCI as the case may be.**
- 7 The period of experience in a discipline / area of work, wherever prescribed, shall be reckoned from the date of acquiring the minimum prescribed educational qualification prescribed for the post and will be reckoned as on the last date prescribed for receipt of Applications.
- 8 Upper age limit will be reckoned as on the last date prescribed for receipt of applications.
