ESIC Medical College PGIMSR & Model Hospital, Rajaji Nagar, Bangalore proposes to fill up the posts of **Junior Residents on contract basis** through **walk-in interview on 04.11.2022**. The details of vacancies and reservation position is as under:

Note:

1. In case of non-availability of reserved candidate's vacancies will be filled against any other category to meet mandatory MCI/NMC requirement.
2. ESIC reserves right to cancel the recruitment process at any stage at its discretion and such decisions will be binding on all concerned.

Candidates claiming reservation on grounds of OBC should submit the community certificate in updated original as per Annexure – A, as prescribed vide Govt. of India, Dept. of personnel and training O.M No 36036/2/2013Estt. (Res.) dated 30.05.2014 failing which benefits of reservation/age relaxation will not be given.

Certificate issued in other format will not be accepted and candidate will be treated as general category for all purpose.

A. Age Limit: Not exceeding 30 years as on date of reporting for interview. (Age relaxation applicable as per Govt. Of India Rules)

- a. The consolidated remuneration of **Rs. 1,08,385/-** will be paid as under as per ESIC Hqrs' Office Memorandum No. Z-17/11/1/2007/Mrf. IV (Pt. file) dated 13.04.2022.
- b. In case of turnout of candidates is more than the ratio of 1:5 per post, the Competent Authority at their own discretion may conduct a screening test to shortlist the candidates for the interview. The Screening test will consist of Multiple Choice Questions in the concerned discipline.
- c. The marks obtained in the screening test will not in any way linked to the Final selection process. The performance of the candidate in the interview will be the sole criteria for selection of the candidate for the respective post.
- d. If the number of candidates appearing for the interview are more than the expected number, then the interview will be continued to the very next day.

Those candidates who have not qualified in the screening test will not be permitted for interview.

B. Terms of Contract:

The contractual engagement will be subject to the following:

- a. The contractual engagement will be terminated giving one month notice on either side.
- b. Candidates selected to the posts of Junior Resident have to deposit an amount of Rs. **1,00,000/-** as security deposit. The security deposit will be forfeited in case the selected candidate resigns/leaves within six months of reporting or non-fulfillment of Notice period conditions.
- c. Other terms and conditions will be applicable as issued by the Competent Authority from time to time.
- d. This is being a contractual appointment, absence for period beyond 15 days will be treated as abandonment of duty and the contract will be terminated without any reason and security deposit will be forfeited.
- e. The Appointment shall not confer any right or preference for regular appointment. Further, such appointments also subject to medical fitness.
- f. The Dean is the Controlling Authority for Junior residents.

The following testimonials should be submitted at the time of Walk-in- Interview:

- (i) Two copy of recent self-attested passport size photograph.
- (ii) Self-attested copies of certificates and testimonials in support of proof of age (Date of Birth), Educational Qualification etc., should be submitted at the time of interview.

- (iii) Certificate issued by competent medical board in respect of Persons with Bench Mark Disabilities.
- (iv) Candidates seeking reservation benefits under SC/ST/OBC/EWS category must ensure that they are entitled to such reservation as per eligibility prescribed in the notice and as per the instructions issued by Govt. of India. They should also produce original certificates in the prescribed format of Govt. of India in support of their claim.

Persons working in Central Government/State Government/Central Autonomous bodies/State Autonomous bodies/Central PSUs/State PSUs/have to produce no objection certificate from their employer at the time of document verification.

C. How to Apply :-

- a. Application shall be downloaded from the website of ESIC viz. www.esic.nic.in.
- b. Selected Candidates should produce all the original documents in respect of all the parameters at the time of Reporting for duty.
- c. Shortlisted candidates who fails to produce documents or provides false information or any other action contrary to law shall lead to barring the candidate for the Interview and shall lead to cancellation of the candidature at any stage.

Selection Procedure

1. The selection will be made on the basis of performance of the candidate in interview before the Selection Board (Read with Para A(b) in the advertisement).
 2. Result will be communicated through e-mail and will be displayed on website.
 3. Selected candidates will have to join immediately after receipt of the Offer of Appointment.
 4. Upon selection of the candidate fails to report on or before the stipulated last date of joining, his/her appointment stands cancelled and the next eligible candidate will be automatically be deemed selected.
- (i) Mere submission of application does not confer any right to the candidate to be eligible for interview unless they report on the scheduled date and time.
- (ii) Application should be submitted in the prescribed format only. The applications submitted in any other format OR incomplete applications will be summarily rejected.

- (iii) The candidates may ascertain their eligibility and report for interview on the scheduled date and time for interview. Candidates reporting after scheduled time will not be allowed to attend the interview process.
- (iv) ESIC reserves the right to cancel the recruitment process at any stage at its discretion and such decision will be binding on all concerned.
- (v) Wrong declarations/submission of false information or any other action contrary to law shall lead to cancellation of the candidature at any stage in addition to suitable legal action.
